The goods shipped under this Sea Waybill will be delivered to the Party named as Consignee or its authorized agent, on production of proof of identity without any documentary formalities. Should the Shipper require delivery of the goods to a party other than the Consignee states on this Sea Waybill, then written instruction must be given to the Carrier or his agent.

Delivery Options for containerized goods: (A) direct unstuffing in the port after expiration of free time period; (B) Carrier haulage arrangements under the inland rates of Carrier payable in advance; and (C) Merchant haulage subject to either deposit with Carrier of full replacement value of the container or other security arrangements acceptable to Carrier.

The Carrier shall exercise due care ensuring that delivery is made to the proper party. However, in case of incorrect delivery, the Carrier will accept no responsibility unless due to fault or neglect on his part.
